- 2018 Regional Public Health Network Jennifer Selfridge
  - 13 regions, 13 RFP submitted, waiting for reply on awards
- RAPS – Regional Access Point Services – 2.1.1. Connects to the NH Addiction Crises line and then to RAPS. Kim Haney, Regional Access Point Supervisor. Her Direct Line is 603-931-3700 And her email is [khaney@granitepathways.org](mailto:khaney@granitepathways.org).

Kim described RAPS services:

- Provides intake evaluations to determine level of care needed.
- Locates support in the individual's home community.
- Schedules appointment with a drug and alcohol counselor for screening.
- Provides case management at 3, 6 and 12 months.
- Provides an insurance navigator for those with no insurance.
- Introduces client to a Recovery Coach

RAPS is currently working on developing satellite offices – Lakes Region and Berlin are possible future sites. Granite Pathways will go where invited. There is no budgeted rent money, but Granite Pathways can help with such things as internet access and utilities. Mary Croasdale discussed the challenge of finding residential placements for those with a criminal record, particularly those with a history of violent offenses, such as assault, arson. IT is especially challenging for adolescence with difficult backgrounds. Pike School and Mt Prospect Academy are options for adolescents to receive services, but they need to be charged with a crime first-

- Through the Delivery System Reform Incentive Program (DSRIP), the State of NH received an 1115 Medicaid Transformation Waiver to support delivery system transformation—rather than to cover the costs of specific services rendered by providers—the waiver will enable health care providers and community partners within a region to form relationships focused on transforming care. This funding will also provide prompt resources for combatting the opioid crisis and strengthening the state's strained mental health delivery system. C3PH is in the Region 7 Integrated Delivery Network (IDN), with North Country Health Consortium serving as our region's Administrative Lead. For complete info go to: IDN 7 Link

This is a five year project that is in the second year, with capacity building funds already being released to organizations to implement programs to improve the integration of primary care and behavioral health care while at the same time helping to address the challenges of those suffering from substance use disorders (SUD).

Specific outcome measures must be met, with measurements focused on the health of the Medicaid population, in order for additional funding to be received in the future.
