IDN update: Full IDN Meeting 3/23, Steering Committee and 4 Workgroups have been meeting

Data Workgroup:

- Health Information Technology Requirements (HIT) The Statewide HIT Taskforce has been working to establish minimum, desired, and optional HIT requirements needed to achieve the goals of the Demonstration Savings Reform Incentive Payment (DSRIP) program. Part of this process is to recommend a vendor that will improve the integration of behavioral health and primary care at a regional level, across regions, and statewide. Each IDN Region will be working to incorporate these requirements at the regional level as feasible. Region 7 IDN Data Workgroup has members that have been part of this Statewide Workgroup, and has been meeting at the regional level to discuss these requirements. We have conducted a regional HIT assessment to see current status.
- Performance Metrics NH Department of Health and Human Services (NH DHHS) has been working to determine what performance metrics will be measured over the course of the DSRIP project, and how these metrics will be gathered. Again, Region 7 IDN has been part of this process, and the data workgroup has been reviewing these metrics and giving feedback

Clinical Workgroup:

- HIT Requirements The Clinical Workgroup has been involved in the discussions around
 HIT requirements and how specific vendors will impact workflow
- Performance Metrics The Clinical Workgroup also has been involved in the Performance Metrics discussion
- Core Standardized Assessments The Workgroup has briefly discussed Core
 Standardized Assessments and what is currently happening at a regional level. There

will be significant focus on this topic moving forward as we work to improve integration between behavioral health and primary care

Community Engagement Workgroup:

- Communication plan The community engagement workgroup has been working to identify the different target audiences with the IDN and how best to communicate with each of these audiences. What do various groups need or want to know to stay informed? The group is working on a newsletter, some brief documents that will help explain the DSRIP project a bit easier, press releases and other communication tools to keep everyone connected.
- o Website the Region 7 IDN website is still underway. It will be rolled out soon
- Basecamp Basecamp is an online project collaboration system to help manage projects and organize documents in one place. Basecamp will be set up for our partners to have access to project descriptions, work plans, updates, working documents, minutes, etc.

In order to get much of this information we have been reaching out to many of our partners to get baseline information and this will continue over the next few months.
