Michael Dewar: White Mountain Visitation Services

- Non-judgmental service focused on safety of child, both physically and mentally, primarily
 younger children currently- starts with intake with both parents, \$80 per visit, located at
 Norcross Circle in North Conway, opened to anyone not a therapist focused on safe visit for child
 with parent, referrals from courts as of now but reached out to schools. See e-mail attachment

Aging with Connection and Purpose

- Marianne Jackson shared that a AARP Livable Communities grant was awarded to MWV Housing Coalition to promote accessory dwelling units (ADU) which all towns must allow. Provides seniors with big homes the ability to have income from an additional dwelling in their home, as well as other residents who would like to construct an ADU on their property, subject to necessary building approvals This is designed to not only help with the housing needs of the senior population, but also our local workforce. The grant funds a display to place on table tops around the county in areas to help get the word out on ADU's. Beth shared that Open Enrollment for Insurance is taking place from Nov 1 to Dec 15th. Minuteman Health will not be available next year. People with Minuteman will need to change plans. The Navigator Program at WMCHC is a grant funded program; hopefully funding will be continued. Part of Navigator responsibility is community outreach. Early Childhood and Early Parenting Support:

- Carroll County Early Childhood Coalition (CCECC) is working on the Community Health
 Improvement Priority of Early Childhood and Early Parenting Support. Meeting the last Tuesdays
 of each month except July, August and December. For more info go to:

 number of families accessing home-visiting programs and children receiving developmental
 screenings. CCECC is one of many early childhood coalitions taking part in a Community of
 Practice through SparkNH, the early childhood coalition for NH: http://sparknh.com/.
- Abby Sparks, of Central NH VNA works with families with children from prenatal to 3 years of age through Healthy Families of America. Abby shared aspects of their home visiting program: http://www.centralvna.org/html/pediatric_program.html. Abby meets clients at home or wherever they are most comfortable. She conducts an intake on what their needs are and connects them with state services to help them and their families, as well as providing parenting training and screening the children using Watch Me Grow/Ages and Stages questionnaire. Home visiting and developmental screening programs and other early childhood programs can address many adverse childhood experiences that may lead to more complex health issues later in life, and are now being considered as prevention programs to address substance use. - SAU9 has Family Support Liaisons at all elementary schools and Kennett Middle School. <u>David Olsen</u> is the located at John Fuller School and <u>Alyson Mcalister</u> is at Kennett Middle School. These positions have proved very valuable in providing the support families need for whatever issues they may face.

Continuum of Care/Access to Comprehensive Behavioral Health Services:

- Catalina Kirsch, C3PH's Continuum of Care Coordinator, presented that she is working on an SUD Assets and Gaps Scan for Carroll County
 - o Prevention, Intervention, Treatment and Recovery focus of COC in Carroll County
 - Top needs that were shared by Roundtable attendees included: concern for teens, police focused on why someone has Narcan rather than the incident it was used in, maintaining recovery coaches is an issue (we need to increase scholarships for recovery coach training and incentive for CRSW), transportation, housing, kids have an entitlement mindset.
 - Still need to engage businesses
 - Priorities: increase awareness and access to services, build capacity of services
 - MWV Supports Recovery is going to Conway Planning Board Meeting on Wed for Occupancy Permit in Conway. Their Endeavor House will provide residence to 8 women to start
 - Whitehorse provides a range of services across the continuum. One idea is to create a sober landscaping crew. For more info contact Eric Moran at emoran@whitehorseac.com
 - Granite Pathways Regional Access Point Service contact for Carroll County Ryan Fowler shared Carroll County calls to help line data from July 30 to Aug 31st
 - o 18 pp called crisis line average age 30,
 - o 10 females and 8 males.
 - o Roundtable attendees were encouraged to advocate for the services of RAPs and the role they are playing in helping people access the SUD services they need.

- 6 students from Kingswood High School went to NH Leadership Program this summer following up with those students to gather feedback on the experience
- We do not only have an opioid epidemic in the community, it is a "substance epidemic". Lance Zack of White Mtn. Restorative Justice shared that meth is appearing as drug of choice in Carroll County, average age of drug use is 13, most start with marijuana with their parents.
