


CCECC formed as a partnership between Children Unlimited, Inc, and Carroll County Coalition for Public Health, serving as a workgroup of the Carroll County Coalition for Public Health's Community Health Improvement Plan addressing early childhood and early parenting support.

Early Childhood & Early Parenting Support Goal & Key Actions

Provide for the optimal development of children and families, ensuring all children enter kindergarten healthy and ready to learn and thrive.

- Increase # of children receiving age-appropriate developmental screenings
- Increase # of families receiving home visiting pre and post-natal services
- Decrease % of uninsured children in Carroll County to zero

CCECC is working in partnership with other regional early childhood initiatives in NH under Spark NH.

Locally, CCECC and School Administrative Unit 9 (SAU9) initiated a community engagement process on early childhood education entitled "*Raising Mt. Washington Valley*". This project was part of SAU9's involvement with NH Department of Education's State Systemic Improvement Plan.


Raising Mt. Washington Valley Goals & Key Actions

- Increase awareness of the importance of early childhood development to ensure that all children in MWV will thrive
- Increase the ability for families to access quality early childhood programming
- Develop a Family Resource Program to ensure that all families have well-coordinated resources for acquiring skills and supports to enhance their children's development and learning from birth through age 5

2017-2018

Coalition work continued at local, regional and state levels culminating with the State of NH receiving \$3.8 million from the U.S. Department of Health & Human Services for a Preschool Development Grant Needs Assessment and Strategic Planning.


Mission & Vision
