DISCUSSION

- Working on implementing Comprehensive Core Standardized
 Assessments, a screen tool for all Medicaid patients, which asks
 questions about social determinants of health and demographics among
 other prompts.
- Social workers conduct the screenings and seem to be finding/identifying concerns earlier. If patient is a child, the CSA is done for the family as a unit.
- Community Health Worker is on staff and works with Social Worker
- Care coordination is becoming more formalized.
- Starting to look at the Transition from pediatrics to adult primary care. Starting conversations with patients 12-14 and their families, to prepare them for self-advocacy and self-management of healthcare at age 18 and beyond. Policy and procedure is being drafted.

MAT Providers and Recovery Supports meeting scheduled for Dec 5, to improve communication and resource sharing between treatment and recovery providers.

Grant proposal for recovery coach response system to IDN7 is submitted and awaiting determination.

CONCLUSIONS

MWVSR strategic plan will include involvement in local efforts to respond to homelessness.

Rose shares that currently they have 5 trained recovery coaches. 3 were trained in CT to work as support in an emergency department setting after an OD and within the first 24 hours to connect individuals to a recovery path.

Support groups are being attended more by family members of a person with substance use disorder more than individuals themselves in recovery.

MWVSR sees a trend of individuals choosing to misuse suboxone. They are working to educate recovery peers. Harm Reduction: local misuse of suboxone includes injection use. Important for health care providers to be on the lookout for bodily signs of injection sites.

Jim Stoddard is providing 1 hr. per week supervision of recovery coaches. Time includes teaching; topics include ethics.
