**Zachary Porter, Kingswood Youth Center:** Dealing with challenges related to COVID and school shutdown. Used remote means to maintain contact. They are distributing food & toiletries to area families. Eric Moran has been a part of weekly Zoom meetings with KYC. Now open under Governor's Summer Camp Guidelines. Trying to help promote social connection. Now providing in-person and remote opportunities. SAU 49 has released reopening plan; KYC needs to work with staff and board to determine fall reopening. **NH Nexus 2.0 (Garrett Lee Smith Youth Suicide Prevention Funding for Carroll County)**: C3PH will be working to assemble an Implementation Team. This project focuses on organizing information and referrals related to care access points for MH crisis and suicide and ensuring aftercare follow-up. Focus on the Continuum of Care (Early Identification/Intervention, Treatment, Recovery) Updates from the Field.

#### **Treatment:**

**Eric Moran, Whitehorse**: New counselor has relocated from New Mexico and a new facilitator from Virginia will be overseeing operations at North Conway location. Still in the process of pursuing a residential treatment site in Ossipee. This project would also open potential for transitional/sober living opportunities. Seeing some appointment cancellations.

**Lynne Sullivan, Groups Recover Together**: Seeing members via telehealth, working on reestablishing in-person treatment. Challenges with finding qualified counselors in the state.

Julie Everett-Hill, White Mountain Community Health Center: MAT is continuing with telehealth but moving toward a hybrid model. Urine and now saliva tests for drug screens- saliva test can be performed in the parking lot. EMR is starting to use a texting system to contact patients (secure text). Challenges related to minutes available on phones. Wi-Fi can help these patients participate in video appointments.

**Heather Phillips, Memorial Hospital**: IMAT has been using telehealth. This has resulted in some increase in appointment attendance, but now starting to see some cancellations. ED is seeing an increase in methamphetamine and co-occurring MH and SUD. Some challenges but also it has been helpful to have recovery supports in ED. Seeing an increase in behavioral health youth patients.

**Denise White, Huggins Hospital**: Huggins Hospital is working with the Foundation for Healthy Communities and the FORE organization to start in-patients who have SUD, but are admitted for other reasons (we will not be an inpatient SUD facility) to create a program using co-design interventions and medications to start people on treatment while they are hospitalized, and set up to continue treatment after discharge.

## **Recovery:**

Janice Spinney, MWV Supports Recovery: Memorial Hospital ED Recovery Support Project - Has served about 25 individuals. Receiving positive feedback from hospital staff/admin. Hoping to sign-on to continue providing ED supports. Pursuing funding for Ed recovery supports. Endeavor House has been certified as a recovery housing provider. Rigorous

inspection process and this is a very positive thing for Endeavor House. Holding a small fundraiser on Silver Lake August 24, 3-5, in Madison. ## **Legislative Updates:**

**Katie Foster, New Futures:** Tobacco 21 is now state law (signed into law by the Governor). Telehealth expansion, Rx drug relief, behavioral health in schools, children's MH all signed into law by the Governor. Telehealth issues will come up again next session. Telehealth will include audio-only for 2 years. FMI https://new-futures.org/

This survey is meant to establish a baseline of what speed and quality of internet service is available in the Carroll County region and where, and whether improved service would be desired by Carroll County residents.
